And, finally, dear church, you have shared the gift of the realness of God's love with the world around you. Be well, dear church, and stand steadfast in the promise of God's love and grace as you take that promise with you into the world.

Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.

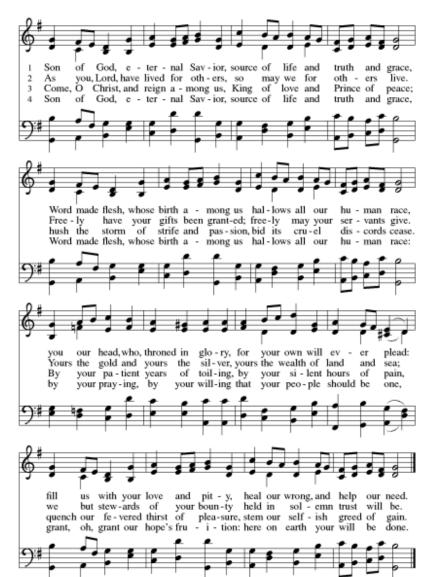
Receive our prayer, O God.

New Business:

2023 Budget: Presented by Marv Isder

To date the loan balance is \$661,448.00. The loan balance is constantly changing as donations come in and we are paying down as rapidly as possible.

Line 1: Increased by 5% for general giving

Line 7: This has been simplified from multiple headings to 1 heading and it is all inclusive to the staff. This year all salaries will have a 5% increase per synod compensation guidelines except for the office staff which will be 2.5% due to coming on later in the calendar year.

Line 21: Insurance is projected to increase so included a 10% increase.

Line 22: Since we have recently done boiler repairs in 2022, we kept the budget around what we spend for 2022 and did not increase by 5%

Line 24: Trying to decrease the amount that is spend by using the liquid ice removal less but this will all be dependent on the weather.

Line 30: Due to the cost of natural gas we are planning on a 10% increase in cost.

Line 31: Due to the cost of utilities we are planning on a 5% increase in cost. Tried to reach out to the cities utilities but they had not had their budget meeting yet so were not able to give an estimated increase.

No questions or further discussion at this time

Motion to approve 2023 Budget: motion by Nancy Marco, 2nd by Harlan Handevidt. Unanimously approved, motion carries.

Building Campaign/Mortgage: presented by Greg Raymo

ALC renewed their mortgage note for another 3 year at 4.5% last year and will renew again in 2025. It is likely that in 2025 if the mortgage is not paid off we will likely see a significant increase to the mortgage interest rate.

Recognitions and Gratitude's:

Thank you to the accounting volunteers: Marv Isder and Sandy Demuth for all their hard work they put into the budget each year. Thank you to Jonathan Horn our IT person that will be graduating from school, he will be close enough to continue helping ALC out with all our IT needs. Thank you to the office and staff volunteers who continue to help the pastors and take a load off their shoulders. We currently have 70 to 75 different volunteers that are helping the church out in many different ways.

Lastly, thank you to our current, out-going, and in-coming council members. Special Thanks to those council members coming off: Connie Voss, Jay Jensen, Kieth Olson, and Laurie Maras. Thank you to Mark Prunty for agreeing to another 3 years.

Pastoral Report from the Lead Pastor

To all of God's beloved Church, American Lutheran Church in Worthington, MN, who walk in the faith of Jesus as we walk with others. Recently, I came across a phrase that captured my imagination as I dwell in God's Word. The biblical commentator was reflecting on Jesus' action in the Capernaum Synogogue as he preached with a new authority and healed a worshipper kept by a destructive spirit. The commentator reflected on how *Jesus was living scripture*. This past year, I have become more aware of how *living scripture* connects us to God's promises and grounds us in the present and prepares us to move into God's future for us.

⁸For I am convinced that neither death, nor life, nor angels, nor rulers, nor things present, nor things to come, nor powers, ³⁹nor height, nor depth, nor anything else in all creation, will be able to separate us from the love of God in Christ Jesus our Lord. (Romans 8:38-39)

2023 began in ways I never imagined. Tending to my dying father with my siblings in 24/7 hospice care was difficult and a gift. This was followed by a sinus surgery that came with a two-week recovery timeframe. The first three months of 2023 were days in which I was separated from you and yet connect through our shared promises of Jesus Christ. It was and is a gift that provided healing grace as I mourned and recovered from a surgery that brought more complications early in the recovery journey.

A vision adopted by the 2021 Church Council has taken hold and we as a congregation are seeing this vision becoming real. Congregational structure is vital to us as an organization. Structure has the power to keep a church from vitality or nurturing it. Structure is behind our worship, team meetings, faith formation classes, Bible studies, and our mission outreach.

In 2021 our congregational structure was a connection of ministry silos divided with the staff and team leaders on one side and the clergy and the church council on the other. It is called the "Lay-Staff Centered Model and it comes with positives and negatives as do all organizational structures.

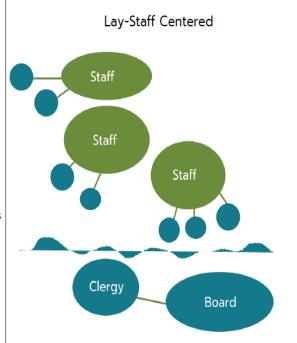
This model was one of isolation, which may have worked well in another era, In the post-pandemic reality a different structure is required to create an organization that was more nimble, adaptive, flexible, and focused on developing relationships and ministry within and beyond our church walls.

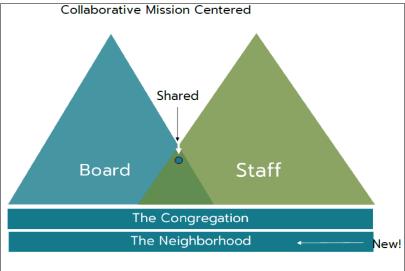
During an April 2021 morning retreat, the church council through prayer and discernment lead by Pr. Peggy Hahn, Executive Director of LEAD adopted a new structure to aid us as we live out present and live into God's future for us.

The "Collaborative Mission Centered" model of church organization (picture on the right) focuses us on Jesus' faith as we walk with others. This has been operational in the background of congregational life. It is shared at staff and council meetings. This model has moved from a vision that was "holy experiment" to a vision "that is grounded in daily reality." Please take time to compare the two models. Begin to see how you as a congregational member and a part of the neighborhood are integral to how we at ALC are participating in God's mission and ministry in this place.

During the Cottage Meetings to discuss the findings of the Congregational vitality study, I framed the results in these words of

Paul to the church in Philippi: ⁸ Finally, brothers and sisters, whatever is true, whatever is honorable, whatever is just, whatever is pure, whatever is pleasing, whatever is commendable, if there is any excellence and if there is anything worthy of praise, think about these things. ⁹ As for the things that you have learned and received and heard and noticed in me, do them, and the God of peace will be with you. (Phil 4:8-9)

After the Cottage Meetings, I tabulated the voting from those events. Eighteen of the thirty-six values of vitality were named as important. The next step was to bring these eighteen values to the church council. Together, the council discussed and named four values as areas of ministry focus for the congregation in 2023, but more for 2024 and the next few years. The four values are 1) participation of ALC's members and friends in ministry and mission, 2) nurturing relationships and spaces of belonging to God and each other, 3) fostering faith relationships with and for children and youth, 4) being an intentionally *vision-driven* congregation.

Thank you to all who took the survey and participated in the Cottage Meetings in March and April of 2024. The Church Council will spend time in prayer and discernment at meetings and a retreat to begin to connect these values to the work we do in Jesus' name.

The Stewardship Ministry Team and I created the 2023 stewardship worship series centered on the theme from Acts 2: 42-47: *Daily they broke bread together with glad and generous hearts*. Thank you to all who are stewarding God's mysteries of good news and grace by completing the yearly commitment/pledge form. More members than any other year in recent history filled out the form indicating that you are invested and committed to the ministry and mission pathways of caring for the congregation and the neighbors as our vision.

In many ways it seems like the Stewardship Season continued into December 2023 and January 2024 with the "Double Your Impact" Debt

Reduction Ministry Campaign. Thank you to the investors that made the matching grant possible. Thank you to all the people, both in person and online givers. Thank you to all the first-time givers and those who give often. Together, we have made the reality of paying off the debt a reality that is not far off.

You will find throughout this entire annual report stories of ministry. Even work on updating the Constitution and Bylaws and our annual budget tell the story of how we walk in Jesus' faith. Thank you to those provided the leadership in these areas. Mission and Ministry

Mission and Ministry met 7 times in 2023 to plan service projects and fellowship opportunities for our congregation.

- 1) We hosted 4 congregational potlucks, in March, July, September and December, serving between 40-80 people at each. We were involved with the set-up, serving, and clean-up at each meal.
- 2) 600 gallons of laundry detergent were prepared and delivered to the food shelves in 2023. 250 of these gallons were prepared by our committee, following our regular scheduled meetings.
- 3) We served 96 people at our Lenten Supper in March. We served a baked potato bar with chili, and many toppings. A total of \$380.00 was earned for the support of Every Meal.
- 4) We participated in the Every Meal project, with ALC sponsoring the Worthington Intermediate School, where 200 meals were distributed weekly from January to May and 171 meals weekly from Mid-September through December. We also helped register the students for Every Meal in August at the Intermediate School. We use 9-10 volunteers each week to distribute to registered students' lockers, immediately after school most Thursdays, for them to take home on Fridays for weekend meals.
- 5) We voted to resume the practice of collecting a "Noisy Offering" on the 4th Sunday of every month, beginning in November, with the collection supporting the Every Meal program.

REPORT of the ETTA JANSSEN MEMORIAL LUTHERAN COLLEGE and SEMINARY ENDOWMENT FUND COMMITTEE for 2023

The estate of Etta Janssen (1895-1973) established this scholarship in 1975. The expressed desire of Etta was that the fund be perpetual and be used for no other purpose than scholarships for seminary and Lutheran college students. The amount to be used for scholarships each year cannot exceed the interest and investment earnings generated. Funds received during the year specifically designated for current distribution are combined with other monies in the fund but are accounted for separately from the fund principle. Funds received during the year that are not designated for current distribution are added to the fund principle.

Scholarship applicants must be a current member in good standing of ALC, have completed one year of college and be enrolled full time in a college or seminary of the Evangelical Lutheran Church in America. Each applicant may receive scholarships for up to three years with and additional three years if preparing for full time church work.

Report of STEWARDSHIP COMMITTEE

Committee members for 2023 were: Pastor Anne Hokenstad, Pastor Jeremy Hallquist, Connie Wienrank, Karla Kirkeby, Kathy Sackett, Lori Ailts, Melissa Jensen and Pat Remme. We met monthly on the second Tuesday evening of each month.

"Because of You" articles were written for the monthly newsletters to help members be aware of the many activities that were accomplished because of their involvement and dedication. Topics were highlighted such as church office volunteers, Manna Food Pantry participation, ALC's assistance to the Intermediate School through the Every Meal program and donation of classroom supplies, involvement in Wednesday night meals and cleaning of the Fellowship Hall floor and chairs.

The "Manna Food Pantry" drive was conducted during March and received \$9,564 through special envelopes and Lenten offerings. The Worthington Regional Health Care Foundation matched our gift by 100%, creating a total contribution of \$19,128. Thank you to all who contributed!

Easter Plant Delivery was held on April 1 as ALC focused on members who had suffered loss of loved ones, who had endured health issues and who had mobility issues. About 30 kalanchoe plants and handmade cards were delivered to members' homes by volunteers. Cards were signed by the pastors. Thanks to all who participated!

Time and Talent Sheets were mailed out in May, inviting members to indicate which areas of ministry they would like to participate in, such as ushering, preparing Communion, assisting with Faith Formation, etc. Thank you to those who offered to help with all areas of ministry!

The Stewardship theme was selected based on Acts 2:43-47: **Day by day, they broke bread together with glad and generous hearts.** The theme was implemented in many ways throughout November – in bulletins, newsletters, sermons, banner, bread-making classes, music and power point slides. A month-long devotional was printed with daily readings written by ALC members.

Stewardship Sunday was celebrated on Sunday, November 19. Members returned their financial commitment forms for 2024. Every worshipper was given a votive candle decorated with the stewardship banner image. Between services the Stewardship Committee hosted a brunch complete with homemade cinnamon rolls, egg bake and fruit.

The Sharing Trees and Christmas Plant Program continues to be a popular Christmas project enabling poinsettias and handmade cards to be signed by the pastors and delivered to 45 members experiencing long-term health issues, mobility issues and loss of loved ones. Poinsettias were delivered to members' homes on December 16 by volunteer drivers. Members selected large paper stars off the Sharing Tree in the narthex, then included the \$10 in the attached envelope to help pay for the plants. Stars on the small Sharing Tree generated baby items which will be donated to Helping Hands Pregnancy Center for use by their clients after the New Year. Thank you to all who participated!

Thank you to members of ALC for reading the articles prepared by the Stewardship Committee, for participating in the projects coordinated by the committee, for completing Time and Talent Sheets and commitment sheets, and for being faithful stewards every day of the year.

Report of Worship and Music Committee

Committee members for 2023 were Aubrey Anderson, Rich Besel, Shauna Carroll, Sherri Isder, Diana Kvilhaug, Mary Turner, Council Rep Mike Peterson, Sylvia Andersen and Pastors Anne Hokenstad and Jeremy Hallquist. The committee met a total of 9 times using a combination of in person and hybrid formats.

In addition to providing regular worship materials with a managing budget and aiding the review of the worship experience, it is the intent of the committee to provide support and encouragement to all staff involved in organizing and enhancing worship.

Three worship times and styles are available each week using in person, livestream and FM 88.3 radio options: Wednesday at 6:30 p.m. – Koinonia worship; Sunday at 8:00 a.m. – First Word worship; Sunday at 10:15 a.m. – Journey worship. Each of these services use the same scripture with a different approach to give congregation members a choice of worship. On the Sunday mornings of December 24th and 31st, one 9:00 a.m. worship service was held. From Memorial Day to Labor Day, the 10:15 a.m. worship time changes to 10:00 a.m.

Three special "Summer Celebration Series" worship services were held this year. Each of these services was held at 10:00 a.m. followed by a meal. Sunday, June 25th was scheduled at the Downtown Pavillion, however windy, rainy weather caused the service and meal to be held at the church. Sunday, July 16th Worship at the Lake was scheduled at Centennial Park, but due to poor air quality, the service and meal were held at the church. The third special and meal, At the Barn, was held at Al and Janice Oberloh's Barn Event Center on Sunday, August 27th. All services were supported by this committee and were well attended! Free will offerings were collected at each service to aid in the support of a Youth Director position.

The committee set the following goals for 2024:

To provide quality TV, radio and online ministry, including updating software, for those not attending worship in person.

To continue to encourage youth as well as adult participation in worship services.

To continue to encourage participation in musical groups and encourage individual musicians to enhance the praise of our worship.

To pursue the idea of hosting an online Sunday worship service at The Meadows and Golden Horizon facilities to give residents a sense of worshiping together with us on Sundays.

The committee will continue to pursue new worship avenues and promote being a warm and caring congregation, welcoming all and sharing Gods love as commanded. We look forward with faith and hope, trusting the Father, Son and Holy Spirit to guide our path into the year ahead!

Annual Report for the 2023 Calendar Year

Worship/Music Ministries and Technology Ministry

The 2023 year has brought continued growth and positive changes!

In the <u>worship/music</u> areas, the "Busker Band" is blossoming with a very committed group of young folks. They share their worship leading in a limited schedule. An electronic drum kit was recently purchased as an addition to the resources for this group.

Our 6:30 Wednesday Worship, "Koinonia", is held most Wednesdays from September through May. The Koinonia experience continues to flourish and begins with a meal, followed by worship and then faith formation opportunities for all ages. All ages of friendly faces serve the meal. Our younger families are embracing this mid-week worship service as it offers them a worship opportunity other than the weekend which is heavily scheduled for most families. The younger folks are volunteering to lead worship elements and man the sound booth. It is a joy to be a part of the energy that this informal worship brings!

Our Sunday morning worship services have been a mix of tradition-based worship and some newer styles and resources. We offered several 'sermon series' that extended our comfort zones a bit! Special worship experiences during the year included: Ash Wednesday, Holy Week services including Maundy Thursday worship and Good Friday Stations in open house style, three Easter Festival Worship services, Pentecost, Reformation & Confirmation, All Saints Sunday, Thanksgiving Eve, Longest Night, and three Christmas Eve worship services.

We continued our tradition of holding an outdoor worship service in the park during the summer and expanded on worshipping beyond our walls. Unfortunately, this year the weather did not cooperate! June's worship was planned to be held at the downtown pavilion but needed to move back to our sanctuary due to a rainy, windy, very chilly morning; July's worship at Centennial Park also had to be held at the church building but this time because of very poor air quality; but, thankfully, the August worship at The Barn could be held as planned!

Another beloved tradition that continues is the Wednesday Lenten services with Evening Prayer services and, of course, the Lenten meal before the service.

Updates on our music groups: The 'small but mighty' Chancel Choir under Rich Besel's leadership has re-grouped and is now titled "Voices of Praise". They currently are scheduled three times throughout the church year with limited, targeted practice sessions. As hoped, this has allowed more singers to participate! The Bell Choir directed by Louise Claussen rehearses on a regular basis and when possible, shares in worship once a month. The choir consists of a core of ALC members and is often enhanced with community folk as substitutes. We were able to assemble an Instrumental Group for Christmas Eve in 2023. In addition, many musicians were able to assist and enhance our three Christmas Eve services.

Our faithful group of worship leaders consists of Aubrey Anderson, Kris Besel, Rich Besel, Ellie Hallquist, Dan Horn, Jocelyn Horn, and Karla Kirkeby. The leaders from the piano and/or organ are Cindy Anderson, Sherri Isder, and Sylvia Andersen. The Busker Band assists whenever possible.

In May, we had the honor of hosting the Inaugural Concert for WAYO – Worthington Area Youth Orchestra – under the leadership of Zac Paulsen and Morgan Rukstales. The concert was held in the sanctuary with an after-concert social time in the Gathering Room. Our facility proved to be a very concert-friendly venue. Opening our doors to the community for hosting events was one of the goals of the remodel.

The <u>technology team</u> has been busy upgrading and maintaining the equipment under their care. Currently, a project to enhance the livestream and recording capabilities is underway. Fun fact: The original installation of this sound system was happening at this time ten years ago! Remember how we watched the booth area take shape under the guidance of RDI and our woodworkers who repurposed several pews for use? The original pew ends with the engraved crosses were incorporated into the design, too! We began using the system in worship in early February of 2014.

Worship services rest on the shoulders of MANY volunteers from Greeters and Ushers to Readers to Musicians to Communion preppers and servers along with many other roles. If at any point, you feel the nudge to participate in this area of ministry, please contact either of the Pastors or myself.

We have often commented that even on our 'bad days', we are blessed to have the support of the entire congregation through volunteering and/or financial support! This is noticed and we are so grateful for this solid foundation. We thank you from the bottom of our hearts!

In conclusion, Colossians 3:16-17 sums up our year beautifully (emphasis mine): ¹⁶ Let the word of Christ^[a] dwell in you richly; teach and admonish one another in all wisdom; and with gratitude in your hearts sing psalms, hymns, and spiritual songs to God.^[b] ¹⁷ And whatever you do, in word or deed, do everything in the name of the Lord Jesus, giving thanks to God the Father through him.

Children & Family Annual Report 2023

Mission:

To provide meaningful opportunities for children and their families to grow in their faith together.

2023 Year-In-Review

50 students are registered for Faith Formation this year. Sunday mornings offer a traditional Sunday school setting, with **15-25 students** who attend regularly. Wednesday's Ignite class – focusing on God's amazing world, through science-based lessons – engages **15-20 kids** each week, and often includes a couple non-ALC kids, invited by friends.

Through the continued generosity of Lutheran Women, we presented **21 Bibles** to **4** preschoolers, **8** first graders, and **9** third graders. Third graders also attended a Bible orientation class in October. In December, **4** of our fifth-grade students made chalices in preparation for their First Communion.

Children & Family Ministry strives to engage kids (and their families) in meaningful ways. In the span of a year, we offer **26** Sunday school lessons, **22** (Wednesday night) "Ignite" lessons, **3** Intergenerational events, **1** community-wide event, and a VBS option. This year, for VBS, we teamed up with **4** local churches to provide a "Community Kids Camp" hoping to reach area kids who normally do not attend VBS programming. We registered **90 students**, with about **75 students** attending each evening. We served an average of **110 meals** per evening.

Our Fall Festival – at The Barn – treated **75 guests** to a fall-themed meal, followed by crafts, games, scarecrow decorating, and a scavenger hunt. To kick off Advent, we hosted a community-wide Journey to Bethlehem event, welcoming **124 guests** into "Bethlehem" to share in the hope and joy of the season. The following Sunday, **35 additional guests** traveled through the stations. This event was the epitome of "intergenerational", and we hope to offer it again.

Children's Ministry requires many hands! Thank you to the **7 teachers** who rotate, to lead Sunday school, each week, and the many volunteers who help with events. The Journey to Bethlehem event, alone, required **19 station leaders**, **3 set-up volunteers**, and **12 people** on the tear-down team.

A gigantic thank you to all who give of your time, energy, and talents to make Children's Ministry happen. And to those who support Children's Ministry, financially...

With your help and God's wisdom, we can discern new paths to nurture faith, fellowship, and service.

Report of Coordinator of Volunteer Ministries

Our Stewardship theme, "Day by day they broke bread together with glad and generous hearts," describes the sense of community and concern for each other which the early Christians demonstrated. The verses prior to this account in Acts 2:43-47, also describe how the believers voluntarily combined their resources and shared them with those who were needy. Do you suppose they designated a small group to collect and count the offerings which were so generously given? Certainly someone in the early Church was accountable for counting, recording and handling the funds appropriately!

Are YOU willing to be such a person in our congregation now over 2,000 years later?

At ALC, we call these members who count, record and handle the funds appropriately the **FINANCIAL COUNTERS.** We respect and trust these folks who demonstrate accountability, confidentiality, timeliness, accuracy and uniformity with our offerings. AND we could use more of them! Perhaps you are willing to join the work of the counters?

What are the Counters' responsibilities?

Counters are divided into teams of four typically, and each team is responsible for handling the offering three months of the year with one member serving as captain.

In the church building, they count the offering either on Sundays or Mondays.

They add up the offerings, double check their work and complete the provided summary sheet using the suggested practices.

A deposit slip is prepared and taken to the bank by the captain.

They maintain confidentiality about offerings received.

Greetings from your camp - Shetek Lutheran Ministries!

This summer we served 770 total campers, which includes our youth campers, cross-generational campers and our SOS campers. We are close to serving as many campers as before the pandemic. 2023 was a 24% increase in camper numbers over 2022 and about 94% of the campers we had in 2019. One of our greatest challenges continues to be finding young adults who are willing to serve for the summer. Our summer ministry team of 20 young adults served faithfully this summer and grew in their faith and in their leadership skills. We were blessed with 7 international counselors this past summer from the United Kingdom, Jamaica, Zambia, Mexico, Zimbabwe and two from South Africa. Shetek will be inviting several international counselors in 2024 also.

Our "Building on the Foundation" capital campaign continues with primarily the congregational phase. Several congregations have run successful campaigns in their congregations so far. We will be contacting all our 100 member congregations to give them the opportunity to participate. We continue to visit with prospective major donors, those who give or pledge \$5,000 or more for the campaign. We have met our phase 1 goal of \$1,500,000 and our total so far in cash and pledges is about \$1,613,000 as we work towards our challenge goal of \$2,000,000. The new lodge is done and is being used by a variety of different groups from scrapbooking groups, Scout groups, family gatherings and college students. The Property Committee and Board are working on plans for the first new cabin and we hope to begin construction in the spring.

Some improvements in 2023 – we upgraded the sound system in the chapel, replaced the reverse osmosis system in the Dining Hall, had to replace the motor on the pontoon, repaired the east wall of the chapel and painted it, painted 3 cabins along with the office, and removed several trees.

I am thankful for our year round staff who continue to work as a team to serve our guests and campers and provide great hospitality. Shetek welcomed Gaelyn Gernentz in March to our Housekeeping team, Deb Ness in June to our Summer Food Service, Joe Koenigs in June to our Maintenance team, and Alexandra Cowell began in September on our Housekeeping team.

We are so grateful for the many campers and guests that came this year. Shetek has impacted so many lives over the years. One of our Counselors in Training (CIT) had this to say about last summer.

"I feel closest to God when I am at camp. I consider camp to be my second home during the summer. This summer, I felt called and was able to have the opportunity to spend about 6 weeks volunteering at camp and I learned a lot. I learned how to respond to stressful situations better, I was able to make, renew, and grow friendships, and I strengthened my leadership skills by helping lead activities like games, worship, reading scripture, and more. I feel that I grow in my faith on a deeper level and grow closer to God everyday there."

Shetek continues to receive estate gifts periodically, which we are very thankful for. Over the years, these thoughtful gifts have really benefitted the ministry at Shetek. For just as the body is one and has many members, and all the members of the body, though many, are one body, so it is with Christ......

Now you are the body of Christ and individually members of it. – 1 Cor. 12.

One of the great joys of my call is to visit the congregations across this synod. Our territory includes vast plains, rich agricultural land, hilly vistas, quiet lakes, and powerful rivers. God planted our congregations in cities, open farmland, and towns. We are very different from each other; yet in Jesus Christ, we all are one.

As we've journeyed together this year, we have been united by focusing on the WORD: Jesus - the Word-made-flesh, and the word of Scripture – as the source and center of our lives.

- Embody the Word. Synod Assembly 2023 brought over 365 voting members together in-person for the first time in 4
 years! We rejoiced to sing again in Christ Chapel, passed the 2025 budget, and elected new leaders. And plenary
 speaker Matt Bloom helped us consider wholistic wellness in daily life.
- Serving the Word Today. Rostered ministers gathered for the Fall Theological Conference and considered how the
 Word is served (our calling to serve Christ) and how we deliver or serve-up the Word to people in our presiding and
 preaching. Presenter Jason Moore provided insights that can transfer in some way to all of our congregations, as we
 serve the Word both in-person and online in our both/and world today.
- Living the Word Today. Equipping Congregations Day 2023 gathered participants at Vinje Lutheran in Willmar to
 discover ministry resources from stewardship to hospitality to take back home. Luther Seminary Professor
 Rolf Jacobson led participants to look for the gifts of the Holy Spirit who is at loose in our world today.

Those actions – *Embody, Serving, and Living the Word Today* - provide the framework for reviewing this year and leaning into the next.

Embody the Word

Thank you for the way you, as beloved children of God, embody the word in your congregations and daily callings. You are engaging in ministry that is vital to the lives of your participants and the larger community. Although many of us are still exhausted from pandemic adaptations, congregations are emerging from these difficult years with a clearer sense of who we are and what God is calling us to be and do today. The dedication of our church leaders to ministries of word and sacrament and serving, to compassion, mercy, and justice - has never been greater.

As we review the past year, one place to turn is the numbers. No, it's not all about the numbers, but trends do tell a story, whether in our households, businesses, or congregations. A synod's responsibility is to note the trends occurring among our congregations because these numbers represent real people, hearing the story of God's love in Jesus Christ.

The most recent statistical summary for congregations comes from the annual reports you completed for 2022. Of the 229 congregations in the SW MN Synod in 2022, 166 filed an annual report; 63 filed no report. When the annual report information comes to you in January, please direct the info to others in your congregation who can assist. Talk with your Church Council about the trends you are seeing. Return the form. And then know you have helped us reach a target of 100% responses this year! Thank you!

What stories do those figures tell? There is the cultural trend of fewer people connecting with a faith community. But these numbers also represent stories of outreach as adults are welcomed through Holy Baptism as hospitality is extended and new members are received, and as people are drawn to worshiping together both in the room and online.

Generosity

We know there is great generosity in our congregations! Although earned income for congregations was challenged last year everywhere, regular giving and other receipts increased. Over the pandemic years, many congregations held special appeals to upgrade technology – what a gift!

You have an impact on human lives every day. Each week in the announcements, try telling a brief story about one of your ministries. Share a photo on a screen. Thank people for their generosity and the difference they are making. If you are looking for resources to help affirm your people's generosity, check out the synod website under the "Generosity" tab! Thank you for the generous Mission Support you shared in 2022. Although current 2023 figures won't be known until after the fiscal year ends January 31, we have seen a significant decrease in Mission Support this year. Why? We know that the cushion of PPP money is used up. Everything costs more. Some of our congregations' most generous givers are passing away or face high costs for elder care. And there is the tendency that when faced with financial challenges, congregations choose to direct funds close to home. Whatever the reason, we will continue to wisely steward the resources we receive and are committed to prioritizing providing pastoral care of congregations and rostered ministers. Like you, we know that challenges can also lead to doing things in new ways, and we trust in God's creative Spirit as we plan for the future. Thank you for your generosity.

If you have not yet sent in a Mission Support contribution for this year, will you please consider a gift yet in January? And if you have not yet returned a Mission Support Intent form for 2024, please do so. We are deep in planning the 2026 budget that will be presented at the 2024 Synod Assembly, and your planning will help us do our best planning, as well. Thank you!

Serving the Word Today

Thanks be to God for all the Lay and Rostered Ministers leading our congregations today. They are serving Jesus and serving the Visible and Spoken Word to people in worship in this synod and far beyond. Our synod includes 300 rostered ministers, half of whom hold active calls in congregations, specialized calls, and synod calls.











This year, we celebrated the ordination of 5 new pastors: Rev. Chad Duffy, Rev. Mort Meyenberg, Rev. Stefan Swanson, Rev. Bob Ossefoort, and Rev. Sarah Zender. We consistently welcome more rostered ministers to this great synod than we see move away.

One of the greatest challenges for congregations and synods today is securing rostered minister leaders who can "serve the Word" in their context. Today, seminaries are seeing approximately half the number of enrollments they did 15 years ago. The good news is that congregations are embracing the gifts of their people and becoming less pastor-dependent than we were. The other piece of good news is that more lay leaders are sensing the Holy Spirit nudging them to consider part- or full-time ministry — often as a second career; and they are bringing incredible skills and life experiences into these new callings today.

TODAY, I pray that God will "send laborers" into this new and changing vineyard of ministry. My mentor, Rev. Dick Vangerud, often spoke of an initiative of our predecessor church body (The American Lutheran Church) called, "Men for the Ministry." Yes, back in the 1960s, the initiative was only about "men" for the ministry! But back then, congregations prayed that God would raise up new leaders. Pastors encouraged those they knew to consider ministry as a life calling. Since we can't grow pastors on trees, this is what I ask you to do:

- Pray in weekly worship and in your own devotions that the Holy Spirit would move hearts for people to consider part- or full-time ministry.
- Notice the people of any age in your church who might have the faith, temperament, and gifts for ministry.
 Affirm their strengths. Ask them if they might pray about and consider ministry in their future.

We are grateful for the ministry of Gifts of Grace that helps rostered ministers reduce the debt from their seminary training, and for the scholarships that are available from so many sources – including this synod, our seminaries, and the ELCA churchwide. Thank you!

For congregations who have rostered ministers leading you, please take care of them by providing appropriate compensation (see our synod compensation guidelines) and benefits. Encourage them to take sabbath time away from work and make use of continuing education growth. Got a concern? Talk to them, not about them. Give them a word of thanks for their ministry, which they serve 24/7.

Whether there are lay or rostered leaders serving the word with you today, strive to live together as the body of Christ. Nothing is more draining of leadership or destructive of Christian community than behaviors which tear apart the body of Christ. At the end of chapter 12, St. Paul tells the Corinthians, "And I will show you a still more excellent way." And that is the way of love - the way of Jesus.

Living the Word Today

These are interesting times to be called and sent by the Triune God to live the Word today! The territory of our synod is described by the state demographer as including areas that are entirely Rural, Town/Rural Mix, Urban/Town/Rural Mix, and Entirely Urban. "Cities, farms, and towns together." As demographic trends continue, the report asks, and we as the church can ask:

- How will we support the many older adults who are part of our communities who may live farther from services and family support?
- · How will we respond to labor force shortages as more Boomers move into retirement?
- How can our churches help our distinct communities to be more attractive to new residents?
- How can churches make a difference in communities with growing racial and cultural diversity, and create connections and belonging?

Those gifts of the Spirit (1 Cor. 12) will lead the way as God continues to reform us to live the Word today.

This fall we celebrated the reactivation of our relationships with our friends in the South Eastern Diocese of Southern Africa. Four guests came to be with us here in Sept. -Oct., and then five leaders from SW MN made the journey to South Africa and were blessed by warm hospitality, joy in our friendships, and new opportunities to accompany one another in Christ. Another gift!

I am grateful for the leadership of our Synod Council, taking seriously its responsibility to be faithful stewards of our resources of staffing, facility, and funding. I am excited to work together with them on the Council's commitment to "empower Christian communities to join in God's mission of reconciliation: listening intentionally, loving unconditionally, serving others authentically, and faithfully healing creation." They have been focusing on the strengths, opportunities, aspirations, and results they see in this commitment, and are eager to live out this vision with you in the coming year.
